

GAMELARDER.COM – UK PRIZE DRAW TERMS & CONDITIONS – JANUARY 2026

4. The opening date for entries is 00:00am GMT on 1st January 2026. The closing date of the prize draw is 23:59pm GMT on 31st December 2026. Entries received after this time will not be valid.
5. The Promoter accepts no responsibility for entries not successfully completed due to a technical fault technical malfunction, computer hardware or software failure, satellite, network or server failure of any kind.
